The Journal of the House of Burgess for ch 1, 1761 (Page 228) records that "Mr. Washington presented e House, according to order, a bill to prevent hogs running at within the Town of Winchester or the limits thereof."

continued as Burgess from Frederick County until July 16, J. A vacancy had occurred in Fairfax County and he, efore, sought a seat nearer home, where it would be easier for to make a canvass and announced for the vacancy, at the same declining election in Frederick.
